10 A RESOLUTION

11 REPEALING RESOLUTION NO. 1998-77 ESTABLISHING THE PARKING ADVISORY  
12 COMMITTEE; RESOLUTION NO. 2014-14 ESTABLISHING THE APPRENTICESHIP  
13 DEVELOPMENT TASK FORCE; AND RESOLUTION NO. 2014-19 ESTABLISHING  
14 THE COMMUNITY HOSPITAL AND HEALTH CARE STUDY GROUP.

16 WHEREAS, the City of Santa Fe currently has close to 50 advisory boards, committees,  
17 commissions and task forces that were created to provide input, support and recommendations to  
18 the Governing Body on relevant issues; and

19 WHEREAS, a few of these committees have not met in several years, have not provided  
20 useful input to the Governing Body, or were designed for short-term goals; and

21 WHEREAS, in an effort to reduce the number of advisory groups supported by the City  
22 of Santa Fe, the Parking Advisory Committee, the Apprenticeship Development Task Force, and  
23 the Community Hospital and Health Care Study Group have been identified as no longer serving  
24 a need of the City; and

25 WHEREAS, reducing the number of advisory committees concentrates the pool of

1 existing quality candidates to be able to serve on remaining committees that continue to provide  
2 useful input to the Governing Body; and

3 **WHEREAS**, the repeal of these Resolutions will reduce the number of advisory  
4 committees supported by the City of Santa Fe; and

5 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**  
6 **CITY OF SANTA FE** that Resolution No. 1998-77 establishing the Parking Advisory  
7 Committee is hereby repealed.

8 **BE IT FURTHER RESOLVED** that Resolution No. 2014-14 establishing the  
9 Apprenticeship Development Task Force is hereby repealed.


10 **BE IT FURTHER RESOLVED** that Resolution No. 2014-19 establishing the
